We are honored to celebrate another year as your non-profit communitybased hospice along the West Michigan lakeshore! For over 40 years, we have made a positive impact by living our mission—providing compassion, comfort, and support to adults and

children experiencing serious illness or grief.

Over the years, Harbor Hospice has embraced innovation and change to stand out from others as a nationally recognized leader and expert in hospice and palliative care services. This year was no exception as we embraced new technology to enhance communication and collaboration between our patients, families, clinicians, and health systems. Enhancements that fully integrated and updated the phone systems at our main office and the Leila & Cyrus Poppen Hospice Residence—as well as our mobile devices—were a priority, along with ensuring reliable connectivity so you can count on us to be available anytime you need us.

In 2024, our reach grew to serving nearly 2,000 patients who were in need of hospice or palliative care across five counties. This report provides just a few of the numbers that reflect the quality, quantity, and scope of services provided by the many dedicated individuals who made that possible. Physicians, nurses, social workers, chaplains, home health aides, volunteers, and others helped ease patients' symptoms such as pain, anxiety, and shortness of breath by wrapping them in our Circle of Care.

Our Leila & Cyrus Poppen Hospice Residence alone served 315 patients in 2024. Throughout 2025, we're celebrating the Poppen's 20th anniversary, marking the work of visionaries and volunteers in the community who recognized that being at home is not an option for all hospice patients. We've also launched a plan to enhance the family rooms, conference rooms, and other shared spaces at the Poppen—areas that have lovingly served more than 5,500 patients and tens of thousands of family members over the years.

We celebrated our 30th year of Camp Courage in June of 2024 at Pioneer Trails with 36 children ages six to fourteen. They spent two nights and three days with counselors and volunteers trained to help them process their grief of losing a loved one—not by themselves, but with other kids and adults who understand. And that still left plenty of time for all the outdoor activities they love like swimming and campfires!

Grief support through our Bob and Merle Scolnik Healing Center includes counseling for those who have had a loved one in hospice, but also reaches beyond to anyone in our communities who might benefit from individual or group counseling, or some of our special programs such as Cooking for One or Coping with the Holidays. As always, there is no charge for our grief support services. A phone call at the right moment from a member of our care team might be just enough, but if you need more, we are here.

As a not-for-profit organization, we depend on community support each year, especially to help cover the cost of programs and services we provide that are not billable and not reimbursed by insurance or Medicare. Year after year, residents and businesses in the communities we serve remind us that just as they are our priority, we are theirs.
